# 1.1. Scope

This Privacy Statement describes the personal information that Company Webcast processes as part of its service to host investor relations, corporate communication and council webcasts on behalf of the organization listed on the registration page ("Organization"). The Organization is the Data Controller of the information.

#### 1.2. Personal Information We Collect About You

We only collect personal information about you which is necessary to fulfill our contractual obligations with the organization. We may collect the following personal information about you:

- This is data, such as your name, e-mail address and company details which you may provide to us during the registration process.
- **Product Usage Data**: This is data we obtain about your viewing of the webcasts, such as the date on which you viewed the webcast, the duration of your viewing and the part of the webcast you viewed.
- Data interaction: Data entered when using the application as ask a question and poll.

### 1.3. How We Use Personal Information

We may use the personal information you provide us for the purpose of fulfilling our contractual obligations with the Organization. Specifically we may use your personal information as follows:

- **Administration**: We may use the personal information we collect about you to provide our webcasts to you (and to assist you in the use of our webcast product).
- **Product Development, testing and improvement**: We may use your personal information to develop, test and improve our webcast product. Company Webcast will not use this data to contact you in any way

# 1.4. Sharing Personal Information

We do not sell or otherwise disclose the personal information we collect about you, except as described here.



**Organization**: We share your contact data and product usage data with the Organization. While Company Webcast accepts no responsibility for the use of your personal information by the Organization, the organization shall generally use your personal information to identify those institutions and individuals who have viewed their webcast and may use that information for their marketing purposes (for example, to contact you directly or to include you in Organization mailing lists).

**Disclosures for Legal Purposes**: We may provide access to your personal information when legally required to do so including, without limitation, to cooperate with government investigations or other legal proceedings. We reserve the right to transfer any information we have about you in the event we sell or transfer all or a portion of our business or assets. Should such a sale or transfer occur, we will use reasonable efforts to direct the transferee to use information you have provided in a manner that is consistent with this Privacy Statement.

#### **IR Manager**

In case of Investor Relation communication data is shared with IR.Manager part of Euronext corporate services. This is for reporting to Organization purposes only.

# 1.5. Security

We maintain administrative, technical and physical safeguards to protect against loss, misuse or unauthorized access, disclosure, alteration or destruction of the personal information you provide to us.

#### 1.6. Cookies

Cookies are small text files that are sent and stored on the user computer, smartphone or other device for accessing the Internet, whenever you visit a website. They are useful because they allow a website to recognize the user device, log when the user visits a particular page or provide a secure connection to a website, etc.

In order to offer and provide a customized and personal service through our products and websites, we may use cookies to store and help track information about you. We only use cookies to provide you with certain functionality and to personalize our product or website content. Without cookies, this functionality would be unavailable. By using our products and websites you agree that we can place these functional cookies on your device.

# 1.7. localStorage, Non-Cookie technologie

LocalStorage is a feature of your web browser that allows us to store small amounts of data directly on your device.

Engagestream has one component that utilize localStorage: The video player (<u>bitmovin player</u>). Below you will find more details:
